ArcSys Hot Tip

When you are in a data entry screen you can take advantage of using the Alt key to perform the functions shown in the buttons at the bottom of the screen. Pressing the Alt key will display an underline below the letter that corresponds with the button and Alt key. Once you see which letter goes with each button you could then perform, say, an Alt P to Print. An Alt C will Cancel. An Alt X will save and exit.

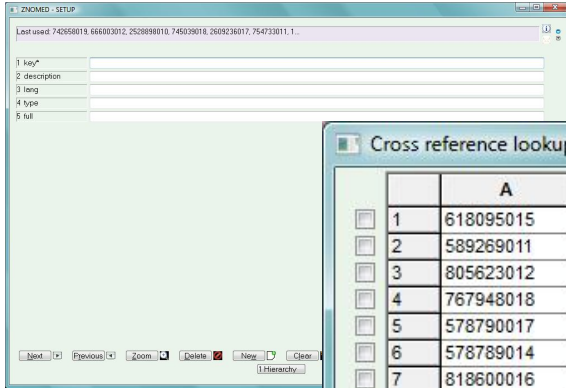

SNOMED Lookup



A new screen is available within the Certification Menu of Red Planet that allows you to become acquainted with the nuances of SNOMED. In the Key field, type in a description of a term or phrase. A cross reference will appear. For this example, the term "BENIGN HYPERTENSION" was entered. The "A" column shows the SNOMED code. The "B" column is known as the Fully Subscribed Name (FSN). The



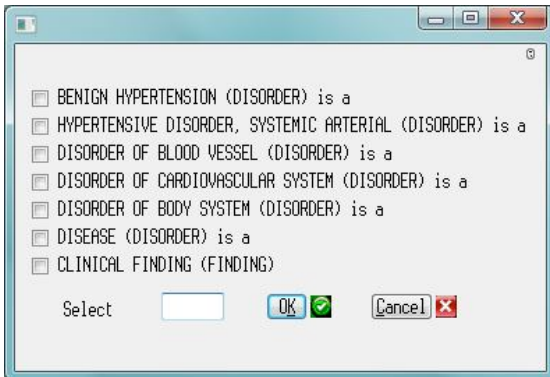

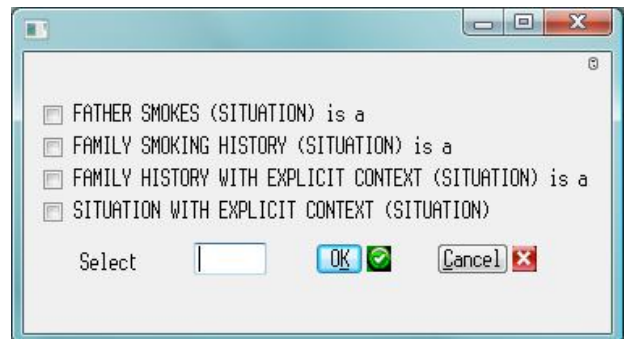
"C" column shows the SNOMED Concept ID number. The "D" column is the language commonly used for this phrase (GB—Great Britain, US—United States). The "E" column shows a P meaning Preferred or A for Acceptable. The "F" column shows a F meaning Full name or S for Synonym. On selecting an entry from the cross reference, the screen will be filled.

At the bottom of the screen is a button labeled Hierarchy. This will show how a specified SNOMED code is organized. Our example of benign hypertension is shown here. You will notice it is classified as a "disorder". For



the most part, what you have been accustomed to thinking of entries in the problem list of the medical record fall under this classification. The genius of SNOMED is this hierarchical structure which systematizes literally, everything known to man.

If you were looking up a SNOMED code "FATHER SMOKES" when recording information for the Family History section, the Hierarchy button would display:



There are three additional cross references

available for lookup. The 2nd is for "disorders" (think problem list), the 3rd is for "situations" (think family history), and the 4th is for "procedures". With practice, you'll become familiar with the way things are worded and you will be able to breeze through the process of utilizing SNOMED in the various screens required for Meaningful Use 2. There are over 400,000 codes available. So you can expect a Wildcard search to take several seconds before you will see your results.
